

Federal Standards for Collecting and Reporting Ethnicity and Race

Starting in 2010-2011, school districts were required to report race and ethnicity using revised standards. The new standards require a person to f rst select his or her ethnicity (Hispanic/ Latino or not non-Hispanic/ Latino) and one or more of f ve race values. Because more than one race value may be chosen, percentages may not add to 100.
